Resolution - Recreational Uses of Scientific and Natural Areas (SNA's)

The following position statement proposed by Larry Kennebeck was passed at the Breckenridge Chapter February 11 Board meeting and has been submitted to the Minnesota Division.

Minnesota has 159 Scientific and Natural Areas (SNA's) that are land or water features owned by the features, water features, and similar. state to protect sensitive, unique, or rare components of nature, such as wildlife, plants, geological features, water features, and similar. These areas tend to be the best of the best that nature has to offer.

The Minnesota DNR is proposing to allow more recreational opportunities at selected state SNA's to increase awareness and support the SNA program (perhaps financially). Public hearings will take place in early 2014 for each of the 15 - 25 SNA's where additional uses are proposed.

Nearly all SNA's are open to the public for activities such hiking, bird-watching, nature photography, education, and snowshoeing. By law the DNR can allow otherwise prohibited activities in an SNA if those activities are compatible with the purposes for which the SNA was acquired; however, changes in public uses at existing SNA's require a public hearing.

Currently 25 SNA's are open to all forms of public hunting and trapping (with dogs) and another 21 are open to all public hunting. Another 18 are open for public hunting of certain, but not most, game species. Fishing is allowed in 28 SNA's.

The types of new recreational uses proposed on 15-25 SNA's include non-commercial berry picking, hunting, trapping, fishing, dogs (hunting or on a leech), and access by watercraft.

We as members of the Izaak Walton League of America are called upon to uphold the principles of conservation. Please dutifully consider approving this resolution and in doing so uphold conservation.

Position

The Walter J Breckenridge Chapter of the Izaak Walton League of America takes the position that:

The DNR should not place an emphasis on added recreational allowances on select or any SNA. Rather the emphasis should primarily be on allowing selective recreation types only as management tools to protect sensitive, unique, or rare components of nature, such as endemic wildlife, plants, geological

Our position on the new recreational uses that the DNR suggests are that:

- Berry picking We don't believe this can be protective of sensitive, unique or rare components of nature. The berries of endemic plants are best dispensed by local birds and animals to help assure their natural and prolific reproduction.
- Hunting We believe that deer, raccoon, and other hunting, maybe out of season, can selectively be considered as a management tool to be protective of sensitive, unique, or rare components of nature in over browsed SNA's. Hunting may be extended to where predation exists to endemic and rare turtle and similar nests.
- **Trapping** We believe that selective trapping, particularly out of season, can selectively be considered as a management tool to be protective of unique or rare components of nature in SNA's where undesirable predation exists.
- Fishing We don't believe this can be protective of nature, unless only rough or invasive fish and aquatic species are selectively caught and removed.
- **Dogs** We don't believe hunting dogs or dogs on a leash can be protective components of nature. Dogs may disturb different species than natural predators.
- Access by watercraft We don't believe this can be protective of nature.
- Parking / access We do not believe that taking a small portion of a SNA for new recreation

- should be allowed because this is not usually protective of sensitive, unique or rare components of nature and diminishes the size of the area or its protective boundary.
- Future SNA's SNA's that are intended to be purchased should allow the above recreation if, and only if, a particular form of recreation becomes a condition of sale.

We are empathetic with the need for additional funds for the DNR, especially for the non-game section. We don't agree that traditional recreation fees, should be used as a funding source for the management of SNA's by virtue of such recreation activities being allowed on SNA's.

Report spells trouble for the Mississippi River Critical Area

New rules for the Critical Area need to protect scenic views of treasured places, like the Mississippi River Gorge between Minneapolis and Saint Paul.

The Mississippi River Corridor Critical Area (MRCCA) was established almost 40 years ago to protect and preserve the unique scenic, natural, and cultural features of the 72-mile section of the Mississippi River flowing through the Twin Cities from Dayton to Hastings. A decade later, the corridor was designated a National Park – the Mississippi National River and Recreation Area (MNRRA).

In 2009, the State Legislature decided that the MRCCA program needed to be updated through a state rulemaking process—in part because the outdated standards and guidelines needed to be consistent with the corridor's national status. When the draft rules were not completed within 18 months, the State Legislature extended the rulemaking authority and required the DNR to submit a report on their progress by January 15, 2014.

While the DNR report to the legislature provides some suggestions for actions that are positive for the river, the majority of the report describes how some of the rules from the 2010 draft will be rolled back or even eliminated in response to local government concerns. These changes put numerous public resources at risk, including the scenic integrity of the corridor.

A number of changes were made to the law in 2013, including the requirement that the DNR consult with local governments before resuming the rulemaking process. The report focuses on this and other minor changes that were made to the Critical Area law in 2013, but in doing so, it fails to address some of the core purposes and components of the statute that

were unchanged. The most troublesome part of the report is the DNR's stated goal to limit regulations that protect scenic views and vistas because they do not fit within the DNR's core mission to protect natural resources. This approach is not in keeping with the law's purpose statement, which requires the MRCCA be managed to "conserve the scenic, environmental, recreational, mineral, economic, cultural and historic resources and functions of the river corridor" (§116G.15, subd. 2).

Specifically, the report states: "The rules will focus more on measures to protect shore and bluff impact zones and other primary conservation areas within the MRCCA, because these measures best protect and enhance water quality and aquatic and terrestrial habitat and can be administered cost-effectively. The rules will focus less on land use, building height, lot size, and visibility of structures; while these measures are still important, they are not as important from a resource protection standpoint and are better left to the expertise in each local government, particularly in areas that are already intensively developed."

(MRCCA 2014 Report, p. 6).

In other words, the DNR states that it will focus only on those resources that fit its mission. Yet John Anfinson, of the National Park Service, points out that State law requires the DNR to write rules to protect all the unique and significant resources of the river corridor, including scenic views as well as cultural and historic features. "The DNR cannot unilaterally abdicate responsibility for some and keep others because they don't fit the agency's mission. State law says they must write rules to protect all the unique and significant resources of the river corridor, including scenic views" says Anfinson. Other concerns about the report include the DNR's intent to change district boundaries, reduce structure setbacks, simplify vegetation management standards and reduce open space dedication requirements. On a positive note, the report suggests changing Metropolitan Council policy to include local critical area plans among the required components of comprehensive plans for corridor municipalities.

"We believe the remaining scenic resources of the Mississippi River in the Twin Cities are worth

protecting and we think that's what Minnesotans want too." said Whitney Clark, FMR executive director.

The report provides a glimpse of the changes being made to the draft rules, which are still on track to be released to the public with an official call for comments in March. It will be extremely important for citizens and other stakeholders to weigh in when the rules are released, to ensure that the public values of the river are given the protection they deserve.

Comments by Darby Nelson:

The DNR is finalizing changes to their draft rules that are to be released to the public in March. The Friends of the Mississippi feel it is extremely important for citizens and other stakeholders to give input during the public comment period to make sure that public values of the river are given the protection they deserve.

Polymet Mine comment period ends soon

The DNR deadline for commenting on the supplemental draft environmental impact statement for the proposed Polymet open pit mine in northeast Minnesota ends March 13, 2014. This copper/nickel mine would be the first in Minnesota. Among the MANY issues concerning this mine is the pollution caused by virtually all previous copper/nickel mines. The pollution threat would last for hundreds of years and would likely impact the Partridge and St. Louis Rivers, and eventually Lake Superior. Other concerns include the loss of wetlands, the foreign ownership of the mining company and the possible costs of cleanup to the state of Minnesota. Chapter House Kitchen Project

Remodeling the Chapter House kitchen has been under discussion literally for years. On February 17 a Building & Grounds meeting was called to discuss it some more and hopefully make some decisions. Attendance was low but included Steve Schaust, John Fraley, Patrice Lindgren & Barbara Franklin. Jim and Judy Arnold and Dick and Vera Brown intended to be there, but health and weather kept them away. We did set some goals and a plan for what needs to be done. Here is a brief report:



Steve's plan is to tear out everything on the south wall, and probably the cabinets on either end of the north wall, keeping the counter pass-thru, but gutting it and rebuilding the storage space underneath, lifting the storage level off the floor and perhaps adding some pull-out shelves/drawers. (I suggested vertical shelving as well for platters & trays.)

Also lower the far (west) end as a beverage center, and perhaps even repair the old coffee maker. And make the cabinets on the other end match the ones on the south side. (It was also suggested at the February 25 meeting that we might consider cutting a pass-thru for beverage service at that end of the kitchen.)

We currently have \$1700 in the Kitchen Fund, thanks to a recent donation, but we will have to determine how much we need to budget and how we'll fund it.

Now we need to:

- Lay out a floor plan with elevations. (Wes has volunteered to take the specific measurements.)
- Decide what appliances we want and what we can get, either through purchase or donations.
 - The two ovens that we have now are pretty essential, especially for holiday parties & pancake breakfasts. Steve said that double ovens are expensive, but it would probably cost just as much to repair the auto-clean on the current one if it's even possible. We may need to get a separate cooktop. Plus a built-in microwave to gain counter space.
 - We don't need anything fancy for the refrigerator, door with shelves that hold something would be a real plus.
- The sink setup is convenient but we need plumbing refurbished & new hardware. The possibility of refinishing the sink was raised.

Suggestions and recommendations are welcome, and now is the time to make them! Please speak to someone on the Board if you have concerns so they can be incorporated into the plans.


